1. **Name of the Society** : **WIDE ANGLE  
(Social Development Organisation)**
2. **Office Address** : **Keishampat, C.C.Pur Parking, Imphal.**
3. **Area of Operation** : **The whole State of Manipur.**
4. **Aims and Objective** :
  - The Wide Angle (Social Development Organisation) Manipur is a non-political, non-sectarian voluntary Organisation. The Organisation shall work without discrimination against religion, creed, gender or language.
  - To act as a clearinghouse of information and knowledge on welfare and development service and for Environmental improvement.
  - To open medical and health centre in area where these facilities are either absent or hard to get with special attention to women and child.
  - To undertake National programmes like HIV/AIDS, malaria, maternity and child health, and universal immunization programme.
  - To plan, implement and support community – based Harm Reduction/Intervention programme; Drug de-addiction programme and projects, Continuum of Care project which are vital for successful implementation of the AIDS control programme in Manipur.
  - To develop appropriate counseling centres and Youth Friendly Counseling Services in the State.
  - To develop training centre, resource centre for effective implementation of the AIDS control programme in the State.
  - To run home for orphans, old aged persons, Youth Centres and destitute as well as physically handicapped persons.
  - To established maintain and conduct weaving, knitting embroidery and other useful art centre for women for further development.
  - To make every youth irrespective of its caste, creed, religion, race gender or language a productive and responsible citizen of the country.
  - To organized and sponsor training programme, workshop, conference, seminars, exchange view, experience sharing, exhibition and to encourage studies and research which will promote the growth and activities of the masses and youth in particular through journal, books, filmstrips, etc.
  - To take up other work/programme not mentioned or inclined in the Aims & Objectives which shall accelerate progress for the Nation as considered suitable by the organisation.

- To receive funds from the Government of India or the State Government and any other Public or Private, national or International funding agencies fro carrying out any of the activities mentioned above.
